The following policy has been established by KSR International Co. / Dresden Industrial to govern the provision of services with Regulation 191/11, "Integrated Accessibility Standards" ("Regulation") under the *Accessibility for Ontarians with Disabilities Act, 2005*.

These standards are developed to break down barriers and increase accessibility for persons with disabilities in the areas of information and communications and employment.

KSR International Co. / Dresden Industrial is governed by this policy as well as the Accessibility Standards for Customer Service Policy and the *Accessibility for Ontarians with Disabilities Act, 2005* in meeting the accessibility needs of persons with disabilities.

Commitment

KSR International Co. / Dresden Industrial is committed to treating all people in a way that allows them to maintain their dignity and independence. We believe in integration and equal opportunity. We are committed to meeting the needs of persons with disabilities in a timely manner, and will do so by preventing and removing barriers to accessibility and meeting accessibility requirements under the Accessibility for Ontarians with Disabilities Act.

This policy will be implemented in accordance with the time frames established by the Regulation.

Accessibility Plan

KSR International Co. / Dresden Industrial will develop, maintain and document an Accessibility Plan outlining KSR International Co. / Dresden Industrial's strategy to prevent and remove barriers from its workplace and to improve opportunities for persons with disabilities.

The Accessibility Plan will be reviewed and updated at least once every five years, and will be posted on the KSR International Co. / Dresden Industrial's

website. Upon request, KSR International Co. / Dresden Industrial will provide a copy of the Accessibility Plan in an accessible format.

Training Employees and Volunteers

KSR International Co. / Dresden Industrial will ensure that training is provided on the requirements of the accessibility standards referred to in the Regulation and continue to provide training on the *Human Rights Code* as it pertains to persons with disabilities, to:

- all its employees and volunteers;
- all persons who participate in developing KSR International Co. / Dresden Industrial’s policies; and,
- all other persons who provide goods, services or facilities on behalf of the KSR International Co. / Dresden Industrial

The training will be appropriate to the duties of the employees, volunteers and other persons.

Employees will be trained when changes are made to the accessibility policy. New employees will be trained during the orientation and onboarding process.

KSR International Co. / Dresden Industrial will keep a record of the training it provides.

INFORMATION AND COMMUNICATIONS STANDARDS

Feedback

KSR International Co. / Dresden Industrial will continue to ensure that its process for receiving and responding to feedback is accessible to persons with disabilities by providing, or arranging for the provision of, accessible formats and communications supports, upon request.

Accessible Formats and Communication Supports

Upon request, KSR International Co. / Dresden Industrial will provide, or will arrange for the provision of accessible formats and communication supports for persons with disabilities in a timely manner that takes into account the person’s accessibility needs due to disability.

KSR International Co. / Dresden Industrial will consult with the person making the request in determining the suitability of an accessible format or communication support.

KSR International Co. / Dresden Industrial will also notify the public about the availability of accessible formats and communication supports.

Accessible Websites and Web Content

KSR International Co. / Dresden Industrial will ensure that our Internet websites, including web content, conform to the World Wide Web Consortium Web Content Accessibility Guidelines (WCAG) 2.0, at Level AA except where this is impracticable.

EMPLOYMENT STANDARDS

Recruitment

KSR International Co. / Dresden Industrial will notify its employees and the public about the availability of accommodation for applicants with disabilities in its recruitment process.

Recruitment, Assessment or Selection Process

KSR International Co. / Dresden Industrial will notify job applicants, when they are individually selected to participate further in an assessment or selection process that accommodations are available upon request in relation to the materials or processes to be used.

If a selected applicant requests an accommodation, KSR International Co. / Dresden Industrial will consult with the applicant and provide, or arrange for the provision of, a suitable accommodation in a manner that takes into account the applicant's accessibility needs due to disability.

Notice to Successful Applicants

When making offers of employment, KSR International Co. / Dresden Industrial will notify the successful applicant of its policies for accommodating employees with disabilities.

Informing Employees of Supports

KSR International Co. / Dresden Industrial will continue to inform its employees of its policies (and any updates to those policies) used to support employees with disabilities, including policies on the provision of job accommodations that take into account an employee’s accessibility needs due to disability. This information will be provided to new employees as soon as practicable after commencing employment.

Accessible Formats and Communication Supports for Employees

Upon the request of an employee with a disability, KSR International Co. / Dresden Industrial will consult with the employee to provide, or arrange for the provision of, accessible formats and communication supports for information that is needed to perform his/her job, and information that is generally available to other employees. In determining the suitability of an accessible format or communication support, KSR International Co. / Dresden Industrial will consult with the employee making the request.

Workplace Emergency Response Information

KSR International Co. / Dresden Industrial will provide individualized workplace emergency response information to employees who have a disability, if the disability is such that the individualized information is necessary, and if KSR International Co. / Dresden Industrial is aware of the need for accommodation due to the employee’s disability. KSR International Co. / Dresden Industrial will provide this information as soon as practicable after becoming aware of the need for accommodation.

Where the employee requires assistance, KSR International Co. / Dresden Industrial will, with the consent of the employee, provide the workplace emergency response information to the person designated by KSR International Co. / Dresden Industrial to provide assistance to the employee.

KSR International Co. / Dresden Industrial will review the individualized workplace emergency response information when the employee moves to a different location in the organization, when the employee’s overall accommodations needs or plans are reviewed.

Documented Individual Accommodation Plans

KSR International Co. / Dresden Industrial will maintain a written process for the development of documented individual accommodation plans for employees with disabilities.

If requested, information regarding accessible formats and communications supports provided will also be included in individual accommodation plans.

In addition, the plans will include individualized workplace emergency response information (where required), and will identify any other accommodation that is to be provided.

Return to Work Process

KSR International Co. / Dresden Industrial maintains a documented return to work process for its employees who have been absent from work due to a disability and who require disability-related accommodations in order to return to work.

The return to work process outlines the steps KSR International Co. / Dresden Industrial will take to facilitate the return to work and will include documented individual accommodation plans as part of the process.

This return to work process will not replace or override any other return to work process created by or under any other statute (ie. the *Workplace Safety Insurance Act, 1997*).

Performance Management, Career Development and Advancement & Redeployment

KSR International Co. / Dresden Industrial will take into account the accessibility needs of employees with disabilities, as well as individual accommodation plans, when conducting performance management, providing career development and advancement to employees, or when redeploying employees.
